

In this regard, the tenth meeting of the Conference of the Parties provides a unique opportunity to respond to the global challenge of biodiversity and meet the needs of present generation and generations to come. Moreover, we need the engagement of all the stakeholders to sustain the wealth of biodiversity on our planet. It is my hope that at this meeting of the Conference of the Parties, a wide range of stakeholders gather in Aichi-Nagoya and join forces for biodiversity and for our common future.

I am Michihiko Kano, and received an appointment to the post of Minister of Agriculture, Forestry and Fisheries.

The tenth Conference of the Parties to the Convention on Biological Diversity(COP10), and the fifth meeting of the Conference of the Parties serving as the meeting of the Parties to the Cartagena Protocol(COP-MOP5) for 2010 will be hosted by Japan. This is a point of tremendous pride for me, particularly given the United Nations' declaration of 2010 as the International Year of Biodiversity and that I can participate in this meeting as Minister of Agriculture, Forestry and Fisheries.

Japan's location in the temperate monsoon zone means that it experiences distinct seasonal changes. October, the month that COP10/MOP5 will be held, is the harvest season, a time when farmers throughout Japan will be busy harvesting their rice. It



will also be when the lovely chirping of nighttime insects can be heard. And just as the meeting is drawing to a close, Japan will be entering the beautiful season of autumn colors, first in the northern regions and then throughout the country.

Japan is an archipelago comprised of some 7,000 islands, both large and small. And on each and every one of them, people are engaged in agriculture, forestry, and fishery that make full use of local characteristics and utilize a broad range of biological relationships.

Particularly noteworthy in Japan is the fact that rural residents' sustainable management of agriculture, forestry, and fishery forms and maintains unique natural environments called satochi, satoyama, and satoumi in Japanese (literally "rural land," "rural mountain," and "rural sea") and contributes to the conservation of biodiversity.

Among the various ways these activities are manifested are paddy fields, which form collected water zone on land. The fields serve an important role in creating various ecosystems that include aquatic animals.

This kind of sustainable use of biodiversity in rural villages allows us to enjoy Mother Nature's abundant gifts throughout the year. It has also given rise to a multitude of cultural traditions that are associated with agriculture, forestry, and fishery. The autumn harvest is the prime example of this.

The Japanese people often say shokuyoku no aki, which means "autumn is the season of good appetite." As this phrase suggests, autumn is a time when food is especially delicious. I hope that when you visit Japan, you will enjoy fantastic dining as you also take in the beautiful natural scenery.

The COP10/MOP5 meeting will be a venue for discussion of some extremely important topics regarding the conservation of biodiversity. Among them will be "establishment of new targets for the conservation of biodiversity," "formulation of international regime for access to genetic resources and benefit-sharing," and "adoption of a supplementary protocol on liability and redress to the Cartagena Protocol on Biosafety." Everyone in attendance will be required to make significant efforts toward resolving these issues. And as the chairman of MOP5, I hereby state my intention to contribute to the meeting's success by reaching beyond these difficult issues.

Recent advancements in science and technology are leading to the emergence of various living modified organisms. The safety of these organisms is attracting considerable concern among the public, and thus all countries will need to work together to ensure their safety. As the chairman of MOP5, and as the person entrusted with food safety in Japan as Minister of Agriculture, Forestry and Fisheries, I intend to tackle this problem earnestly and proactively.

I look forward to seeing you in Nagoya.

Welcome to Aichi Prefecture.

The tenth meeting of the Conference of the Parties to the Convention on Biological Diversity and the fifth meeting of the Parties to the Cartagena Protocol on Biosafety (COP 10, COP-MOP 5) is the first global conference of the parties to be held in Aichi Prefecture. We are greatly honored to host the meeting, and we welcome you particularly in 2010, the International Year of Biodiversity.

Aichi Prefecture is located almost in the center of the Japanese Archipelago and has developed as a region blessed with bountiful



historical and cultural resources, where the rich variety of nature, vigorous industries, and cities with high transportation convenience exist in harmony. Today, Aichi Prefecture is Japan's most active manufacturing region as exemplified by the automobile industry. In an effort to promote the smooth operation of COP 10 as the host region, the administrative bodies of Aichi Prefecture and the business community got together and established the Aichi-Nagoya COP 10 CBD Promotion Committee in September 2008. The Committee has since been working to inspire local communities to join forces toward the success of COP 10 through biodiversity awareness-raising activities while making careful preparations to support COP 10.

It is our great honor to have the tenth meeting of the Conference of the Parties to the Convention on Biological Diversity (COP 10) in our city in 2010, the International Year of Biodiversity, and we cordially welcome you who have come all the way to Nagoya from across the world.

The Summit also aims to further expand local action for biodiversity by exchanging information and sharing experiences in innovative efforts toward the conservation and regeneration of biodiversity that local authorities have actually implemented.

Nagoya is a city with the population of 2.25 million and plays a leading role in the politics, economics, and culture of the Chubu region of Japan. Since ancient times, it has prospered as a hub of transportation, and today, it still continues to develop with manufacturing industries, such as automobiles, aerospace, and fine ceramics. On the other hand, it is also home to a diversity of living creatures in the Fujimae Tidal Flats, registered wetlands under the Ramsar Convention, in the west and Higashiyama Forest, in the east.

This year marks the 400th anniversary since the inception of Nagoya City and a variety of events are being conducted during COP 10. In addition, as part of our major cultural program to pass the techniques, the spirit of manufacturing, and precious natural environment on to the next generation, we are implementing a project to restore the donjon of Nagoya Castle. There also remain many historical assets in Nagoya, including the Atsuta Shrine with a history of 1900 years. I hope you will have an opportunity to visit these sites while staying in Nagoya.

I sincerely hope that the COP 10 meeting in Nagoya will see many fruits and that your stay in Nagoya will be a pleasant and memorable one.

Hello everyone. My name is MISIA and I've been appointed honorary ambassador for COP 10.

Since assuming my post as honorary ambassador for COP 10 in March of this year, I've visited numerous locations in connection with biodiversity. In addition, I've endeavored to promote awareness of biodiversity through every facet of my activities. These activities have taught me that biodiversity is the foundation upon which our lives are fully built and supported.

I've been involved for some time in supporting education for African children and should note that this region is also one that has suffered from a serious loss of biodiversity. Environmental



destruction wrought in the face of development and modernization has rendered it no longer possible to engage in traditional lifestyles alongside the natural world and more difficult to maintain self-sufficiency. I am also aware that impoverished people are consequently forced into harsher living conditions. I think the loss of biodiversity is connected to all the issues.

Satoyama rural landscapes that have been around for a long time in Japan are likewise disappearing. While the residents of satoyama rural landscapes coexist in harmony with local animals and plants and utilize nature on a sustainable basis, these landscapes can no longer be maintained due to the impact of shrinking populations and the aging of society. As these landscapes fall into ruin, the growing inability to harness nature on a sustainable basis is becoming a significant concern. In other words, the collapse of communities has led to a transformation in ecosystems.

I believe that humanity is ultimately to blame for the loss of biodiversity attributed to development and the loss of biodiversity attributed to the inability to maintain patterns of sustainable use. I've also come to realize that the solution to this issue hinges to a great extent on the desire of local residents in these areas to protect their own habitat. We mutually depend on plants and animals and at times live in a state of opposition and competition with other species. I believe that such ties are also linked to our well-being and happiness.

As the International Year of Biodiversity, 2010 represents a huge opportunity to get people to learn about biodiversity and to think about what they can do to protect this concept.

I implore everyone participating in COP 10 to transcend international borders and sex-based differences to utilize your knowledge and awareness according to your expertise and experiences and take the opportunities offered by COP 10 to steer this world towards a better direction.

It is my sincere desire to see COP 10 succeed in getting as many people as possible to learn about biodiversity and partake in actions together with everyone else gathered here today towards our common goals.






Aerial view from the north



Floor Plan (1F)








Floor Plan (2F)









Floor Plan (3F)





At the COP 10 opening ceremony organized with the concepts of the host country Japan's unique features and biodiversity, shinobue (Japanese traditional flute) performance and hand shadow pictures fuse together and produce a fantastic atmosphere.

Shinobue is a traditional Japanese flute, which has been handed down to us since ancient times as a flute that heals people's minds. It is a unique musical instrument in that it still retains its original, eco-friendly bamboo form without any modern improvements having been added. Ms. Deva Yoko, a shinobue player living in the host city of Nagoya, will give a performance.

In tune with the shinobue performance, the Japanese landscape that changes with the seasons and hand shadow pictures that depict biodiversity will be shown on a large screen set on the stage. The hand shadow pictures will be performed by the Kakashiza Shadow Theater, the first of its kind in Japan. Enjoy the mysterious world and a diversity of creatures made by the hand shadow pictures.

<Profile of Deva Yoko>

Lives in Nagoya. Graduated from Kunitachi College of Music where she majored in flute. Later learned traditional Japanese music.

She began music performance as a professional shinobue player around 1979.

Later she traveled Asia looking for folk music, which served to open the door to her spirit. Since then, she has been playing the shinobue, whose sound comes out of a non-conscious locus deep inside her spirit.

<Profile of Shadow Theater Kakashi-za>

Shadow Theater Kakashi-za was established as the first theater group specialized in shadow pictures in Japan in 1952 by Tairyu To.

Shadow pictures emit a mysterious and attractive aura that stimulates the imagination of every person.

With the aim to foster dreams in the minds of as many people as possible with the aura of shadow pictures, the group has presented its unique performances through TV, movies, stages, and publication for 50 years since its inception.



Profile of MISIA, COP 10 Honorary Ambassador



Since her debut in 1998 with "Tsutsumikomuyoni," MISIA has released a number of great songs, including "Everything" and "Aitakute Ima," and gained popularity across Asia. Her exceptional talent goes beyond music and prompted her to join the G-CAP (Global Call to Action Against Poverty) campaign in Japan in 2005. In 2008, she sponsored the "Africa Benefit Live Yokohama" to raise public awareness of issues in Africa and around the world. She also participated in an event together with Bono and Youssou N'Dour of U2 calling for the eradication of poverty. Since 2008, she has been actively involved in global social action programs, such as educational support activities for children in developing countries.

In March 2010, in honor of her past outstanding service, she was appointed an honorary ambassador for the tenth Meeting of the Conference of the Parties to the Convention on Biological Diversity by the United Nations. In May of the same year, she joined mudef, a foundation with the aim of raising public awareness of global issues via music and art, as a board member.

In August, her new song "Life in Harmony" was produced by David Foster, world-renowned music producer. Foster spoke highly of the song with the theme of biodiversity.

Performing Arts (Owari Daiko)

Owari Daiko (drums). Nagoya's traditional performing art, will be presented at the COP-MOP 5 opening reception.

Owari Daiko has been passed down to the present from the late Edo period, approximately 200 years ago. The tradition has been handed down in the Owari region, particularly in Ama-gun, Aichi Prefecture, where, praying for good harvests and the safety of residents, floats with a small golden house parade through villages during the shrine festival while sounding the drums. Owari Daiko is the drumming technique of such festivals and has been altered to match the present day. Centering on Aichi Prefecture, the drums have been performed across the country and overseas, including China, Vienna in Austria, Singapore, and Spain, where it was extremely well received. Please enjoy the simple, delicate, yet dynamic sounds of Owari Daiko.

<Profile of Yasui School Ryuho Koyokai>

Yasui School Ryuho Koyokai was established by Shigenari Yasui, the head of the school, in 1994 by integrating a folk ballad group in Nagoya and the Owari Daiko group called Ryu no Kai. The group has performed around the world, including performances during the Expo in Aichi, "Ai Chikyuhaku." Its simple, delicate, dynamic performance has been well received around the world.

Performing Arts (Vocal Mimicry)

The COP 10 opening reception presents a collaborative performance between mimicry by the fourth Edoya Nekohachi and music.

The Japanese people are familiar with the mimicry of a variety of animals, insects, and birds from ancient times—the sound of insects and the songs of birds have become part of our daily lives.

The first Edoya Nekohachi elevated his mimicry skills to the realm of art about 100 years ago. The art has since been passed down to the fourth Edoya Nekohachi who will perform today.

Please enjoy the harmony between mimicry, an art that the rich nature of Japan has given birth to, and music familiar to you.

<Profile of the Fourth Edoya Nekohachi>

1949 - Born in Tokyo. Later engaged in the performance of mimicry that was handed down to him by his grandfather.

2009 - He succeeded to the fourth Edoya Nekohachi. He is good at the mimicry of animals and birds and has performed on TV and radio programs and in theaters. He has also given lectures on culture, health, and the environment across the country. He was honored with the Japan Broadcasting & Entertainment Grand Prix, Best Father Award, Art Festival Excellence Prize by the Agency for Cultural Affairs, and other awards.

Side-events and Exhibitions

Inside and outside the Nagoya Congress Center (NCC), various participants of the meeting will introduce their efforts related to the agenda of COP 10/MOP 5 via side-events and exhibitions. 





The Interactive Fair for Biodiversity, taking place in the Shirotori area adjacent to the Nagoya Congress Center, will be an international exhibition providing opportunities for presentations and interaction under the theme of biodiversity. At the Fair, national and local governments, international organizations, NGOs/NPOs, academic institutions, private enterprises, and many other exhibitors from around the world will present their projects, initiatives, ideas, and issues related to biodiversity at display booths and through other means.



Exhibitions/Presentations, and Interaction for the Future

4. Excursions and Other Events

Excursions to enable participants to experience the exceptional natural environment, history, traditions, culture, industrial technologies, and other facets of Nagoya, Aichi and the Chubu region will be held primarily on October 23 (Saturday) and 24 (Sunday) by the Aichi-Nagoya COP 10 CBD Promotion Committee, the governments of the prefectures comprising the Chubu region, and national government organizations. All excursions will feature English-language interpretation services. There will be no charge to participate in these excursions.

Since spots are limited in number, registrations for participation are generally accepted on a first-come-first-served basis. If you have registered for participation, you will be given an excursion participation ticket on which will be written the course name and rendezvous point. You will be requested to arrive at the rendezvous point with your ticket in hand.

October 16 (Sat.) and 17 (Sun.)

Exploring the eternal history and culture of Etchu, Toyama: visiting gassho-style villages (World Heritage Site) and Zuiryuji Temple (a national treasure)

This is a highly romantic excursion designed to introduce you to the history and culture of Etchu, Toyama, elements of which include villages of gassho-style houses in Gokayama that are the pride of Toyama Prefecture, Takaokazan-Zuiryuji Temple, and the Suiboku Museum of Toyama, where the beauty of Japanese culture can be savored.



October 23 (Sat.)

Fujimae Tidal Flat (wetland registered under the Ramsar Convention) and the Port of Nagoya Public Aquarium

Visit the Fujimae Tidal Flat, which was registered under the Ramsar Convention of 2002 as an internationally important wetland due to its status as a vital stopover for migratory birds, as well as the Port of Nagoya Public Aquarium, where marine life is researched.



October 23 (Sat.)

Satoyama Kaisho Forest and the industries of Nagoya, Aichi

Participants will visit Kaisho Forest, a satoyama zone that was originally intended to be a site for the Aichi World Expo held in 2005, as well as museums showcasing automobiles and ceramics, which are key industries based in Nagoya, Aichi.

Beautiful valley of the Kisogawa River and Inuyama Castle (national treasure)

This excursion entails a visit to Inuyama, a town that is situated in northern Aichi Prefecture and that features the Kisogawa River and other splendid examples of natural beauty as well as the vibrant vestiges of a historical castle town.

Ceramics and brewing on the Chita Peninsula

Protruding south from Nagoya, the Chita Peninsula is an area that has long made use of the geographical advantages of this place in terms of maritime trade and other factors to flourish as a center of Tokoname ceramics and other forms of pottery and as a center of saké, vinegar, and other forms of brewing.

Encountering a black-walled village and migratory butterflies on Sakushima Island

A small island floating in the calm waters of Mikawa Bay, Sakushima is home to 300 people engaged in agriculture and fishing. The art projects made possible by the use of captivating streetscapes and a natural environment comprising Mikawa Bay Quasi-National Park are popular among tourists drawn to the slow life.

Shirotori Garden and Nagoya Horikawa historical sightseeing cruise

Stroll through Shirotori Garden, a Japanese garden situated next to the Nagoya Congress Center (where COP10 will be held), before taking a cruise on the Horikawa River, which was dug out along with the construction of Nagoya Castle 400 years ago and which has since then played a role in the distribution of goods in Nagoya. Tour guidance is provided by the Nagoya Welcome Warrior Corps.

Agriculture in harmony with living things and traditional arts

Enjoy strolling through senmaida (terraced rice fields) in Yotsuya, an area located in eastern Aichi Prefecture where agriculture is practiced in harmony with living things, while enjoying the sights of a Japanese landscape from earlier times.

The Suzuka Mountains and Mt. Gozaisho, an area full of natural wonders and home to many plants and animals

Explore the status of biodiversity in the mountains and satoyama zones located in Komono-cho, Mie Prefecture on the outskirts of Nagoya City.









October 24 (Sun.)

Manufacturing and traditional culture in Nagoya, Aichi

Visit facilities that tell the historical story of Nagoya, which began with the construction of Nagoya Castle in 1610, before checking out museums where you can be introduced to the history of modern industry, upon which manufacturing as the foundation of industry in Nagoya, Aichi was built.

Higashiyama Forest and contemporary art exhibition Aichi Triennale 2010

Visit Higashiyama Forest, a large urban forest stretching across a hilly zone in the eastern part of Nagoya, and drop by Aichi Triennale 2010, a cutting-edge contemporary arts festival.

Miya Festival and Okazaki

This excursion features a visit to two cities: Gamagori, a town facing the sea in eastern Aichi Prefecture, and Okazaki, famous for a brand of miso seasoning paste renowned as a representative specialty product of Aichi made from soya beans.

Biodiversity in a satochi/satoyama landscape in the basin of the Yahagigawa River and in the Yanami Bog

The Yahagigawa River running through central Aichi Prefecture is a clear stream constituting the source of drinking water for the residents of the river basin. Participants will be treated to a tour of the riverside forest along this waterway, a satoyama rural landscape, and a bog that exists as a habitat for unique indigenous plants.

400 years of biodiversity conservation issues relating to Nagoya, a city of estuaries

Nagoya is a showcase of coastal and urban development in Japan through which changes in the relationship between biodiversity and humans are easy to trace. The southern section of the Nagoya Congress Center was once a part of the sea. The city of Nagoya has been developed through a series of landfill works since the early years of the modern era to give rise to its geography as we know it today. This excursion explores the human activities that were lost and altered during the course of development as well as the tidal wetlands and forests that survived this process.

Biodiversity conservation in the Dando National Forest in the context of sustained forest management

Dando National Forest once belonged to the Imperial family. Since the Meiji Period, Japanese cedars and hinoki cypresses have been planted here, such that over ninety percent of the forest today has been artificially cultivated. In such an artificial forest, one can see a rich diversity in terms of the ages and composition of trees achieved thanks to the appropriate stewardship of the forest. This area is also home to protected forests of Japanese beech, fir, and Japanese hemlock trees, only a few of which remain in Aichi Prefecture. Participants will gain an understanding of biodiversity conservation efforts as applied to Japanese forests while being briefed by members of the Forest Agency in charge of managing this site.





October 23 (Sat.) and 24 (Sun.)

Eco-tour to Ise Shrine, which has existed in a state of symbiosis with nature for 2000 years, and Ise-Shima

This eco-tour explores Ise Shrine, a sacred site with a proud history going back approximately 2000 years nestled amid deep forests, and allows participants to gain a first-hand look at efforts to restore the sea at Ise-Shima, engage in conservation projects, and otherwise coexist with nature in a state of harmony.

The biodiversity that allows the Japanese crested ibis to flourish and Sadogashima, a place steeped in history and culture

Participants will pay a visit to Sado City, where a system for the certification of the development of villages in which residents can reside in harmony alongside the Japanese crested ibis has been established to take advantage of the ongoing recovery of the oppulation of this species in the wild. Agricultural practices that take biodiversity into consideration are being promoted. An environmental brand of rice is being sold at premium prices to help promote the restoration of ecosystems.

The castle town of Kanazawa and the satoyama/ satoumi landscape of the Noto Peninsula

Explore the castle town of Kanazawa, a place of rich history and culture once known for its rich harvests during feudal times, and the Noto Peninsula, where one can come across traditional scenes of farming and fishing even today.

Mikata-goko Five Lakes (wetland registered under the Ramsar Convention) and a dinosaur museum

Discover the Mikata-goko Five Lakes and Nakaikemi Marsh, which have been registered under the Ramsar Convention, the Fukui Prefectural Dinosaur Museum, one of the three largest dinosaur museums in the world, and more.

Fifth station of Mt. Fuji and Yatsugatake

Visit the foot of Yatsugatake, from where you can gaze lovingly upon Mt. Fuji in the distance, and the fifth station of Mt. Fuji itself to come into contact with the natural environment, history, and culture of Yamanashi.

Kirigamine Plateau and Matsumoto Castle (national treasure)

This excursion will take you to see the extraordinary natural environment and cultural and historical facilities of the central and southern parts of Nagano Prefecture, home to such sites as the Kirigamine Plateau, located in the Yatsugatake-Chushin Kogen Quasi-National Park, and Matsumoto Castle, formally designated a national treasure.

Shirakawa-go (World Heritage Site) and Goshikigahara Forest (Gifu Treasure)

Experience the exquisite natural environment, history, and culture of Gifu Prefecture by exploring Shirakawa-go, a village of gassho-style houses that has been registered as a World Heritage Site, and the Goshikigahara Forest, which in turn has been officially recognized as a treasure of Gifu.

Shizuoka, home of Mt. Fuji

Savor the rich natural environment of Shizuoka Prefecture, as represented by Mt. Fuji, as well as the history of Kunozan Toshogu Shrine, the culture of tea villages, and so much more.

Exploring the relationship between water and people by the shores of Lake Biwa: staying at a farmer's home and touring the lakeside district

Stay a night in a farming village by the shores of Lake Biwa and experience the charm, life, and culture of ancient Lake Biwa, the largest lake in Japan and one of the finest lakes in the world.



Biodiversity EXPO in Moricoro Park

Expo 2005 Aichi Commemorative Park that was the venue of EXPO 2005 AICHI, JAPAN (2005 World Exposition, Aichi, Japan) held in 2005 under the theme of "Nature's Wisdom", provides space to experience and learn about biodiversity while enjoying an abundant natural environment.

Mayors Conference on local Action for Biodiversity, held in Bonn, Germany (May 2008)

As one of the objectives of the Convention on Biological Diversity, the conservation of biological diversity requires initiatives taken not only at the national level but also at the local level. The role of local authorities, those responsible for implementing policy measures in the communities, has become crucial.

As our lives deeply rely on natural resources around the world, conservation of biodiversity is also an issue that must be addressed on a global scale. Therefore it is essential for local authorities from around the world to convene and exchange information.

As a venue of COP 10, Aichi Prefecture and the City of Nagoya will hold the City Biodiversity Summit in order to reaffirm the importance of cities and biodiversity, while calling for further expansion of local action.

At City Biodiversity Summit 2010, local authorities from around the world will gather to share information and exchange their experiences in handling development and managing biodiversity.

The Summit outcomes will be consolidated in a declaration to be presented at COP 10 High Level Segment, introducing initiatives taken by local governments worldwide.

Exterior Exhibition (in the Interactive Fair for Biodiversity)

The Government of Japan will join the "Interactive Fair for Biodiversity" and set up 14 display booths and a tent in Shirotori Park (see p.78 for its display areas). Its various efforts related to the COP10/MOP5 agenda, which have been carried out within the country, and efforts to build international frameworks will be introduced.

1 Interactive Fair Tent of Japan

Efforts by the Government of Japan regarding the COP10/MOP5 agenda will be introduced via panels and the screening of DVDs for publicity. Since this tent is designated as one of the venues for side-events organized by the CBD Secretariat, the side-events by domestic and overseas organizers, including the Government of Japan, will also be held here.

1 Government of Japan

Introduction of the activities through exhibitions and sessions by Government of Japan and government-affiliated organizations as below, relating to COP10/MOP5 agendas.

1-1 Ministry of Agriculture, Forestry and Fisheries

Introduction of the activities for biodiversity conservation and sustainable use of natural resources in the sector of agriculture, forestry and fisheries in Japan, including "Living creature mark", "Promotion of farm land consolidation", "Proper management and conservation of forests such as human-induced", "Fishery resource management, reservation and restoration of fishing ground environment".

1-2 Ministry of the Environment

Focusing in particular on the state of biodiversity in Japan and activities concerned with its conservation and sustainable use, specific efforts, including measures for the implementation of the National Biodiversity Strategy of Japan 2010, an international partnership for collection and use of biodiversity data and information in Asia-Pacific region, the Ramsar convention on wetlands, measures for migratory birds, measures for endocrine disrupting chemicals (EDCs) implemented by the Ministry of the Environment, the results of the monitoring by citizens and children of wildlife, a progressive approach in eco-tourism, and carbon offset, and activities of Japan National Committee for IYB are presented.

1-3 Ministry of Land, Infrastructure, Transport and Tourism

Introduction of experiences and technologies contributing to the balance between development and biodiversity in Japan.

1-4 Ministry of Economy, Trade and Industry

Introduction of the activities on implementation of the CBD-ABS by Government of Japan and government-affiliated organizations.

1-5 Ministry of Foreign Affairs

Japan International Cooperation Agency : Introduction of achieving Harmony Between Human Activities and the Environment: JICA's principle and projects for biodiversity conservation.

1-6 Ministry of Education, Culture, Sports, Science and Technology

National Museum of Nature and Science : The exhibition is about the concept of biodiversity, biodiversity of Japan and conservation activities in Japan.

Japan Aerospace Exploration Agency : Exhibition on contribution of satellites to biodiversity survey, climate change monitoring and forest monitoring.

Japan Agency for Marine Earth Science and Technology : Introducing our approach such as data integration, analysis for ecosystem, in situ observation and remote sensing.

National Institute for Fusion Science : Using a miniature model, posters, videos and other materials, we intend to make an appeal widely for understanding about how fusion energy could contribute to the realization of a sustainable global environment.

Research Institute for Humanity and Nature : Studies on biodiversity and ecosystem service under human activities and the institution of biodiversity conservation are shown.

We are planning to have sessions between the Host Country and the representatives of NGOs during COP10/MOP5. We will inform you time and place at Nagoya Congress Center.

Environmental Considerations

The Tenth meeting of the Conference of the Parties to the Convention on Biological Diversity (COP 10) and the Fifth meeting of the Conference of the Parties serving as the Meeting of the Parties to the Cartagena Protocol on Biosafety (COP-MOP 5) are scheduled to discuss new strategic plans for the future, including "Post 2010 Targets," and "Access and Benefits-Sharing" relating to genetic resources, "Liability and Redress" for damage caused by genetically modified organisms, and other important topics. Approximately 8,000 people from 193 countries and territories are scheduled to attend COP 10/MOP 5, and the energy used and waste generated accompanying the movement of the participants and the holding of the conference will create a large environmental load.

Since COP 10/MOP 5 are meetings of parties to an environmental convention and protocol, it is desirable for the environmental load accompanying the conference to be limited as much as possible.

For this reason, for COP 10/MOP 5 we have referred to the environmental considerations taken for the international conferences held to date and the environmental guidelines for events announced by various countries to reduce the environmental load on the location where the conference is to be held as appropriate. Following is an introduction to the environmentally friendly considerations being taken to hold COP 10/MOP 5.

Also introduced are the things for which we wish to ask your cooperation during the conference, so we ask for your understanding and cooperation to also make the conference a success in considering the environment by reducing the environmental load as much as possible during the conference.

1. Environmental Consideration for COP 10/MOP 5

For COP 10/MOP 5 we have referred to the environmentally friendly considerations taken for the international conferences in the past and the environmental guidelines for events and have planned environmentally friendly measures that participants can understand and cooperate with.

1.1 Environmental guidelines for events and measures taken for past international conferences

In recent years, increasing consideration has been given to environmental concerns of events, such as international conferences. Internationally as well, a guideline for environmentally friendly events, GREEN MEETING GUIDE 2009 (UNEP), has also been published, and in Japan, the Promoting Environmentally Friendly Conventions" (Ministry of the Environment) has been published.

At the previous COP 9/MOP 4, environmentally friendly conference bags were distributed, waste was separated, the use of eco cars was promoted, local-production-local-consumption catering was employed, green power was used, carbon offset for the greenhouse gases (GHG) emitted was implemented, and other measures were taken. In Japan as well, at the Hokkaido Toyako Summit and G8 Environment Ministers Meeting (Kobe), low-polluting vehicles were introduced, natural energy was utilized, energy saving measures were promoted, waste was reduced, and green procurement was promoted among other measures to take environmentally friendly actions as much as possible and to achieve carbon offset using Certified Emission Reductions (CER)

1.2 COP 10/MOP 5 Activities Policy

To implement the latest trends in environmentally friendly events for COP 10/MOP 5, care will be taken to make events environmentally friendly while referencing both domestic and foreign environmentally friendly guidelines. Domestic GHG reduction

and absorption credits will be used to offset for the domestically emitted GHG portion while Kyoto credits will be used to offset the foreign emitted GHG portion, such as for international flights. Further, these carbon offset activities have been certified by a third party organization.

In addition, these measures will be well publicized to gain the cooperation of not only the organizers and related enterprises, but also of the participants to make this an event where everyone involved with COP 10/MOP 5 is unified in taking action.

2. Specific Environmentally Friendly Measures

Reducing the environmental load of the COP 10/MOP 5 will be promoted through such measures as green procurement, 3R promotion, energy and resource conservation, and reducing the environmental load of transportation.

A self-evaluation of the environmentally friendly measures implemented will also be conducted after the conference.

2.1 Green Procurement

When procuring products and services, priority will be given to items with the smallest possible environmental load to lead to creating an appropriate consumption and minimum waste society.

In the holding of the conference, enterprises will be subcontracted to handle a variety of operations including running the conference, inviting participants from overseas, setting up exhibitions, interpreting, printing, and catering. These subcontractors will also be required to take thorough environmentally friendly measures to reduce the environmental load of the conference.

• When procuring products and services, priority will be given to items with the smallest possible environmental load (green procurement).

 \cdot Enterprises contributing to COP 10/MOP 5 will be encouraged to set environmentally friendly policies.

 \cdot Lumber from forest thinning will be utilized for some of the products used at COP 10/MOP 5 (chairperson's desk, country name plates, and benches.

2.2 3R Promotion

Achieving a recycling-oriented society requires the promotion of "Reduce" (reducing the generation of waste), "Reuse" (reusing products), and "Recycle" (recycling resources). Since a large number of people will be gathering at the conference, there is the possibility a large amount of waste will be generated, so the implementation of these 3R will be promoted.

· Only the number of the items required for distribution are being produced.

· Trash will be separated in compliance with the standards of Nagoya.

• Trash separation stations will be established at the conference and separation advice will be provided by volunteers.

• The Skyview Restaurant in the Nagoya Congress Center will provide an all-you-caneat buffet so that the participants will only take the food they will eat.

2.3 Energy and resource conservation

There are limits to the available energy and resources. Effectively utilizing these and reducing waste will lead to achieving a sustainable society.

COP10/MOP5 will also use renewable energy and practice thorough facility energy management.

 \cdot Solar panels have been installed at the venue to supply part of the electric power used.

• Credits have been purchased for the green electricity produced by Aichi prefecture as part of the electric power used by the Nagoya Congress Center.

• Thorough venue energy management, such as adjusting the air conditioning temperature settings, will be employed to reduce the amount of energy wasted.

2.4 Transportation environmental load reduction

One of the environmental load factors accompanying conferences and events is the large amount of GHG emissions produced from the travel of participants and visitors.

For COP 10/MOP 5, using of public transportation will be promoted and eco cars used to reduce the environmental load created by travel.

• Free subway passes will be distributed to all participants to promote the use of public transportation.

• Plug-in hybrid cars will be used to run COP 10/MOP 5.

2.5 Carbon offset

Although various environmentally friendly measures are taken, GHG are still emitted accompanying travel and the use of energy. For COP 10/MOP 5, carbon offset will be used for the GHG that cannot be eliminated.

• The GHG generated from energy used for the conference, by participant airline and train travel, and for other purposes will be calculated as accurately as possible over as wide a boundary as possible.

• To improve the carbon offset reliability, carbon offset certification has been obtained from a third party organization based on the carbon offset certification standards of the Ministry of the Environment.

• The credits selected to use for carbon offset are being selected by a study committee of informed people that has been established. Priority will be given to using the emission reduction and absorption credits ^{% 1} earned in Japan to offset the domestically generated GHG, and CER and other Kyoto credits and offset credits (J-VER) ^{% 2} will be used to offset the foreign generated GHG from international flights, etc.

• Since the carbon offset cannot be directly observed, a report will be published and the information actively disclosed after the offset is completed to provide transparency.

^{**1} Kyoto credits, which are credits issued in accordance with the procedures prescribed by the Kyoto Protocol, are used to achieve the reduced targets based on the Kyoto Protocol. These credits include the Certified Emission Reduction (CER) credits issued through the Clean Development Mechanism (CDM) project jointly conducted by advanced and developing countries.

2.6 Self-evaluation

It is not only important that environmentally friendly activities be planned, but also that they be executed. A review of the activities after the event is over can also be used as a future reference.

The enterprises involved in setting up and running COP 10/MOP 5 will be asked to check their achievement rate for the environmentally friendly policies and to conduct a post-event evaluation.

3. Participants are Requested to Cooperate with the Following

We can reduce the environmental load with the unified cooperation of participants in implementing the environmental considerations for the conference.

3.1 Green procurement

The environmental load from consumption can be reduced by carefully considering the necessity of products and services before purchase and purchase items with as small an environmental load as possible.

There are a variety of environmentally friendly products in Japan. One guide for product selection is the Environmental Label. Please refer to these labels when purchasing products.

3.2 3R Promotion

Extensive cooperation from participants is indispensable for promoting the efficient use of resources. Please cooperate with the following activities.

• Trash separation stations have been set up in the venue. Please separate your trash at the separation stations following to the 11-item separation rules.

• To limit the amount of food wasted, please only take as much food as you will eat in the all-you-can-eat buffet style cafeteria, etc.

· Refuse unnecessary items that are being distributed.

• Congress bags will be distributed at the venue. Please use this bag and do not accept plastic shopping bags, etc.

 \cdot A tumbler will be distributed as a congress item. Please use this to the use of throwaway containers.

3.3 Energy and resource conservation

Energy conservation is an indispensable environmental consideration. Please also cooperate with the following activities to reduce the wasting of resources.

• Extended meetings will increase the energy used for electricity, air conditioning, etc. Please cooperate in the smooth running of the conference to keep down the amount of energy used.

· Please be careful not to leave doors and windows open to reduce the energy used for air conditioning.

· Immediately shut off the spigot when using water in lavatories.

 \cdot In lavatories and other areas, please turn off the lights when you are done to save electricity.

3.6 Dissemination of information

Participants can spread environmental awareness by promoting the environmental friendly activities undertaken by the conference.

• Please use your blog or Twitter to promote the environmentally friendly actions undertaken by the conference and encourage them to take action.

3.7 Request

It is estimated that holding and running this conference will generate more than 30,000 tons of CO2.

Various signs in the conference area will promote 3R and energy and resource conservation.

The cooperation of each individual is important. We respectfully request your cooperation.








Public Transportation


Points to Remember in an Emergency

The most dangerous action in an emergency due to an earthquake is to add to the confusion at the venue by panicking. Since NCC buildings have robust quake-resistant structures, please remain calm and follow the announcements or instructions of the security officers.

The Other Precautions



Smoking in a crowd is a very dangerous act as it might burn people and clothing. In Nagoya, four areas of Nagoya Station, Sakae, Kanayama and Fujigaoka are designated as "Public Nonsmoking Area".



Smoking is prohibited on any street designated as "Public Nonsmoking Area". Not only while walking and riding a bicycle, but also stopping, smoking is not allowed. You may not keep a lit cigarette. Offenders shall be imposed administrative fines of ¥2,000. We ask for your cooperation in keeping the public space safe and comfortable for all.
